

## CONTEST OFFICIAL RULES

**THIS CONTEST IS ONLY OPEN TO CANADIAN RESIDENTS (EXCLUDING QUEBEC) WHO ARE REGISTERED TRAVEL AGENTS AND IS GOVERNED BY CANADIAN LAW AND THE LAWS OF THE PROVINCE OF ONTARIO.**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING.** POTENTIAL WINNER MAY BE REQUIRED TO EXECUTE PRIZE ACCEPTANCE DOCUMENTS AND RETURN THEM WITHIN FIVE (5) DAYS FROM DATE OF ISSUANCE OF NOTIFICATION, AS MORE FULLY DETAILED BELOW. BY ENTERING, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SPONSORS (DEFINED BELOW) FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

**SPONSOR:** The sponsors of the Contest are Qatar Airways located at 181 Bay Street, Toronto – ON M5J2T3, Canada and Tourism Authority of Thailand, located at 130 King St W, Suite 620 Toronto ON M5X 2A2 (“**Sponsors**”).

**CONTEST DESCRIPTION AND TIMING:** The “BAXTER MEDIA QATAR AIRWAYS X TOURISM AUTHORITY OF THAILAND” Contest (the “**Contest**”) begins on November 25, 2019 at 9:00 a.m. Eastern Time (“**ET**”) and ends on January 25, 2020 at 5:00 p.m. ET (the “**Contest Period**”). At the end of the Contest Period, a random drawing will be conducted to select one (1) potential winner of a Grand Prize, from among all eligible entries received during the Contest Period, as set forth more fully below. Entry in the Contest does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsors which shall be final and binding in all respects. Void where prohibited by law.

**ELIGIBILITY:** The Contest is open only to residents of Canada (excluding residents of Quebec) who have reached the age of majority in their respective province or territory of residence and who are a registered travel agent. Employees of Sponsors, and its parents, subsidiaries, divisions, affiliates, representatives, agents/mandataries, suppliers, distributors and advertising, promotional and judging agencies, including the administrator of the Contest if any, and the immediate family members (spouses, parents, children and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win.

**HOW TO ENTER:** **There is NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY to participate in the Contest. A purchase does not improve your chance of winning.**

During the Contest Period, you may enter the Contest by visiting the Contest site at <https://www.travelpress.com/win-qatar-thailand-trip/> (the “**Contest Site**”) and following the instructions to complete the entry form with the information requested and click “Submit”. Upon completion and submission of the entry form, you will receive one (1) entry into the Contest.

All entries must be received by the end of the Contest Period in order to participate. Proof of entering information at the Contest Site is not considered proof of delivery to or receipt by Sponsors of such entry. Sponsors’ designated computer shall be the official time keeping device for the Contest. Use of computer programs and other automatic means to enter the Contest is prohibited and will result in disqualification.

Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void such entries and will result in disqualification. Normal Internet access, usage charges and/or mobile usage imposed by your online service or mobile provider may apply. Entries made by any other individual or any entity, and/or originating at any other website or e-mail address, including but not limited to commercial contest subscription notification and/or entering service sites, will be declared invalid and disqualified for the Contest. Tampering with the entry process or the operation of the Contest, including but not limited to the use of any device to automate the entry process, is prohibited and any entries deemed by Sponsor, in their sole discretion, to have been submitted in this manner will be void. In the event of a dispute as to any entry, the authorized account holder of the email address associated with the entry in question will be deemed to be the entrant, but only if that person meets all other eligibility criteria for the Contest. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof that he or she is the authorized account holder. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsors’ satisfaction, the affected entry will be deemed ineligible. Sponsor, its parents and affiliates, and each of their respective owners, officers, directors, employees, agents/mandataries, representatives, vendors, suppliers, licensees, successors and assigns (collectively, the “**Contest Entities**”) shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the processing of the entries in the Contest. The Contest Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. Any communication or information transmitted to Sponsors and/or the Contest Site by electronic mail or otherwise is and will be treated as non-confidential and nonproprietary. Entries become the exclusive property of the Sponsors and will not be returned or acknowledged. **As a condition of entering the Contest, each entrant gives consent for Sponsors to obtain and deliver his or her name, email address and other information to third parties for the purpose of administering the Contest and complying with applicable laws, regulations and rules.**

**WINNER SELECTION AND NOTIFICATION:** At the end of the Contest Period, the potential winner will be randomly selected in a drawing from all eligible entries received throughout the Contest Period. The drawing will be conducted by Sponsors or their third party administrator, using randomization methods selected by Sponsors or their third party administrator in their sole discretion. The drawing will be held on January 26, 2020 at 5:00pm ET at 181 Bay Street in Toronto, Ontario, Canada. Odds of winning a prize are dependent upon the number of eligible entries received during the Contest Period. The potential winner will be notified via email. Sponsors shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond by email within seven days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate potential winner may be selected. Sponsors may successively attempt to contact up to two potential winner(s) of an applicable prize in accordance with such procedure, and if there is still no confirmed potential winner(s) of such applicable prize after such attempts have been made, such prize may go unawarded.

**PRIZES/ODDS:** There is one (1) prize available totaling an approximate retail value (“**ARV**”) of \$16,000 (the “**Prize**”), as more fully described below. The Prize consists of a trip for the winner of the Prize (the “**Prizewinner**”) and his or her travel companion to Thailand, which includes:

- (i) round-trip business class air transportation for the Prizewinner and his or her travel companion between Montreal, Quebec, Canada and Bangkok, Krabi, Phuket or Chiang Mai, Thailand (ARV: \$8,000);

- (ii) 10- nights deluxe hotel accommodation with daily breakfast in a twin-shared room for 2 guests in one of selected destination mentioned in (i), private round-trip transportation between arrival airport and hotel in Thailand, one full-day sightseeing excursion for 2 guests (ARV: \$8,000). This land package reservation must be requested at least 14 days before the trip.

The Prizewinner and his or her travel companion must be at least the age of majority in their jurisdiction of residence in order to redeem the Prize and participate in the Prize activities. The Prizewinner and his or her travel companion must take the trip between the months of January–April 2020. The Prizewinner flight tickets must be issued by/before 14th March, 2020. The flight tickets are valid for three (3) months from the date of issuance. Return travel must be completed within this 3-month period. No extensions will be permitted. The flight reservations are subject to seat availability and blackout dates as determined by Qatar Airways. The Prizewinner and his or her travel companion must travel together on the same itinerary and must possess all required travel documents, including visas and valid passports, if and as applicable, and comply with any applicable hotel check-in requirements, such as presentation of a major credit card. Medical and travel insurance is not included in the Prize, it is a responsibility of the Prizewinner and his or her travel companion.

All aspects of the travel portions of the Prize must be conducted on such dates as determined by Sponsors in their sole discretion. The dates of departure and return are subject to change at Sponsors' sole discretion. Airfare may not include government taxes and baggage fees. Airline tickets are non-refundable/non-transferable and are not valid for upgrades and/or frequent flyer miles. Other travel restrictions and blackout dates may apply. All airline tickets are subject to the vagaries of flight variation, work stoppages, and schedule or route changes. The ARV for travel prizes may vary depending upon points of departure and destination and fare fluctuations. Sponsors reserve the right to structure travel routes and select hotels in their sole discretion. The ARV for travel prizes is an estimate made before the Contest begins. The Prizewinner will not receive cash or any other form of compensation if actual travel costs are less than the estimate made in these Official Rules. The roundtrip air transportation element for any travel prize begins and ends at the point of departure. No interest will be awarded on cash prizes. Room taxes and other hotel fees are not included and if applicable may be payable at the time of check-out by the Prizewinner/guest. A deposit or payment in advance, or presentation of a credit card by the Prizewinner, may be required at the time of check-in at the hotel. Any hotel cancellations or changes to hotel reservations after confirmation must be made with the hotel directly, and the Prizewinner is solely responsible for any charges and/or fees arising from changes made directly with the hotel. The prize restrictions/conditions stated herein are not all-inclusive and the Prize described above may be subject to additional restrictions/conditions, which may be stated in the Prize Claim Documents (as defined below) and/or other travel documents. In the event the Prizewinner and/or his or her travel companion engages in behavior that, as determined by Sponsors in their sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsors reserve the right to terminate the trip or other applicable experience early, in whole or in part, and send the Prizewinner and/or his or her travel companion/s home with no further compensation.

All expenses and incidental travel costs not expressly stated in the Prize description above, including but not limited to, ground transportation, meals, incidentals, passenger tariffs or duties, surcharges, airport fees, service charges or facility charges, personal charges at lodging, security fees, taxes, gratuity or other expenses are the sole responsibility of the Prizewinner.

No cash alternative or substitution of prizes will be allowed, except Sponsors reserve the right in their sole discretion to substitute prize(s) of comparable value if any prize listed is unavailable, in whole or in part, for any reason.

**GENERAL PRIZE CONDITIONS:** The Prize will be awarded only if the potential prizewinner fully complies with these Official Rules, including correctly answering the contest entry multiple choice skill-testing questions about Qatar Airways and Thailand, without assistance of any kind. All portions of the

Prize are non-assignable and non-transferable. Prizes pictured in point-of-sale, online, television and print advertising, promotional packaging, and other Contest materials are for illustrative purposes only. Actual Prize may vary from the prize pictured. All details and other restrictions of the Prize not specified in these Official Rules will be determined by Sponsors in their sole discretion. No cash alternative or substitution of the Prize will be allowed, except Sponsors reserve the right in their sole discretion to substitute prize(s) of comparable value if the Prize listed is unavailable, in whole or in part, for any reason. The Prizewinner shall be solely responsible for all federal, provincial and/or local taxes, and the reporting consequences thereof, and for any other fees or costs associated with the Prize. The potential winner may be required to execute a Declaration of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, “**Prize Claim Documents**”). If any potential winner fails or refuses to sign and return any requested Prize Claim Documents within (five) 5 days of Prize notification, including, but not limited to, correctly answering the multiple choice skill-testing questions about Qatar Airways and Thailand, the potential winner may be disqualified and an alternate potential winner may be selected. The potential winner’s travel companion must sign a Declaration of Eligibility and a Liability Release prior to any travel documents being released.

Sponsors make no warranties, and hereby disclaim any and all warranties, express or implied, concerning any prize furnished in connection with the Contest, to the fullest extent permitted by law. **GENERAL LIABILITY RELEASE/FORCE MAJEURE:** By participating in the Contest, entrants agree to be bound by these Official Rules, the privacy policy of Sponsors located at <https://www.qatarairways.com/en-ca/legal/privacy-policy.html> and <https://thailandinsider.com/privacy-policy/>, and the decisions of the Sponsors. Acceptance of a Prize constitutes permission for the Contest Entities to use that winner’s name and/or likeness, biographical information, and/or entry for purposes of advertising and trade and on the winner’s list without further compensation, unless prohibited by law. By submitting an entry, you warrant that all of the information provided as part of your entry is accurate, does not violate any third party’s legal rights (including without limitation rights of privacy and publicity) and otherwise does not violate applicable law. Entrants agree that the Contest Entities (A) shall not, to the fullest extent permitted by applicable law, be responsible or liable for, and are hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to participation in the Contest or any Contest-related activity, or from entrants’ acceptance, receipt, possession and/or use or misuse of any prize, and (B) have not made any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize’s quality or fitness for a particular purpose. Sponsors have the right in their sole discretion to disqualify any individual who is found to be tampering with the

entry process or the operation of the Contest or the Contest Site, to be acting in violation of these Official Rules, or to be acting in an unsportsman-like or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Contest, or to annoy, abuse, threaten or harass any other person, and Sponsors reserve the right to seek damages and other remedies from any such person to the fullest extent permitted by law. Sponsors reserve the right to modify, extend, suspend, or terminate the Contest if they determine, in their sole discretion, that the Contest is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsors' control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Contest as contemplated herein. In the event an insufficient number of eligible entries are received and/or Sponsors are prevented from awarding prizes or continuing with the Contest as contemplated herein by any event beyond their control, including but not limited to fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, provincial or local government law, order, or regulation, public health crisis, order of any court or jurisdiction, or other cause not reasonably within Sponsors' control (each a "**Force Majeure**" event or occurrence), then subject to any governmental approval which may be required, Sponsors shall have the right to modify, suspend, or terminate the Contest. If the Contest is terminated before the designated end date, Sponsors will (if possible) select the potential winner in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Only the type and quantity of prizes described in these Official Rules will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners, or remaining winners, as the case may be, of the advertised number of prizes available in the prize category in question may be selected in a random drawing from among all persons making purportedly valid claims for such prize(s). Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. These Official Rules cannot be modified or amended in any way except in a written document issued in accordance with law by duly authorized representatives of Sponsor. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

**CONSTRUCTION:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrants and the Sponsors in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the Province of Ontario without giving effect to its conflict of law rules and provisions. All entrants consent to the jurisdiction and venue of the Province of Ontario. All entrants expressly agree that the Ontario courts shall have sole jurisdiction over any dispute or litigation arising from or relating to this Contest and agree to submit to the laws of and the jurisdiction of the federal courts of Canada and provincial courts of the Province of Ontario, and hereby waive the jurisdiction of any other court that now or in the future could be considered competent for any reason. The venue shall only be Toronto, Ontario.

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. If any provision is determined to be invalid or otherwise unenforceable, these Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

These Official Rules and all Prize Claim Documents have been translated into the French language. However, the English language version of these Official Rules and/or all Prize Claim Documents are the official versions of these documents. In the event of any conflict between the English language version and French language version of these Official Rules and/or any Prize Claim Document or question of

interpretation of the French language version of any of the same, the English language version shall control in all respects.
