

Los Cabos Tourism Board - Canadian Travel Press Sweepstakes
OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. INTERNET CONNECTION REQUIRED. VOID WHERE PROHIBITED BY LAW. NOT OPEN TO THE GENERAL PUBLIC.

PROMOTION DESCRIPTION: Los Cabos - Canadian Travel Press (“Sweepstakes”) starts on or around August 30, 2019 at 12:00:00 a.m. Eastern Standard Time, and ends at 11:59:59 p.m. Eastern Standard Time on October 25, 2019 (“Promotion Period”). At the end of the Promotion Period, a random drawing will be conducted from among all eligible Submission Entries received during the Promotion Period to select one (1) Grand Prize winner, as more fully set forth below. Sponsor’s computer is the official clock for this Contest. Entry in the sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. The sponsor of this Contest is Los Cabos Tourism Board (the “Sponsor”). The Sweepstakes shall be subject to these “Official Rules,” (“Rules”) and by entering, all participants agree to be bound by the terms and conditions herein.

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF CANADA (EXCLUDING QUEBEC) WHO, AT TIME OF ENTRY, ARE EMPLOYED AS TRAVEL AGENTS, HAVE RECEIVED THE LOS CABOS SPECIALIST TRAINING CERTIFICATE, ARE A CURRENT SUBSCRIBER TO CANADIAN TRAVEL PRESS MAGAZINE AS OF AUGUST 4, 2019, ARE TWENTY-ONE (21) YEARS OF AGE OR OLDER, AND HAVE INTERNET ACCESS. THIS CONTEST IS VOID OUTSIDE THE AREA SPECIFIED ABOVE AND WHERE PROHIBITED BY LAW. Question answers will not be judged of effect entry. Valid entrants will receive one (1) Sweepstakes Entry. **LIMIT ONE (1) SUBMISSION ENTRY PER PERSON DURING THE PROMOTION PERIOD.** For purposes of this Sweepstakes, a “Day” commences August 30, 2019 at 12:00:00 a.m. Eastern Standard Time, and ends at 11:59:59 p.m. Eastern Standard Time on October 25, 2019 (“Promotion Period”). By completing the foregoing during the Promotion Period, you will be entered into the Sweepstakes and each individual submitting such Entry shall be an “Entrant.” **ALL ENTRIES MUST BE RECEIVED BY 11:59:59 P.M. EST ON OCTOBER 25, 2019.** Winner must meet the eligibility requirements set forth in these Rules in order to qualify for the Grand Prize. Automated entries (including, but not limited to, entries submitted using any robot, crypt, macro, or other automated service) are not permitted and may be disqualified and may cause Entrant disqualification from Sweepstakes. All Entrants must have a valid e-mail address. Los Cabos Tourism Board and/or Sponsor shall have the right to disqualify any Entries or Entrants for any reason or no reason including, but not limited to Entries and Entrants that Los Cabos Tourism Board and/or Sponsor has determined, in its sole

Sponsor, in its sole discretion, may accept a technically incorrect Entry. Los Cabos Tourism Board's and/or Sponsor's decisions are final and binding with respect to all matters relating to this Sweepstakes.

PRIVACY POLICIES: Personal information, and such use of personal information, supplied by Entrants will be subject to the Sponsor's privacy policy. **WINNER SELECTION AND NOTIFICATION:** At the end of the Promotion Period, on or about November 25, 2019 Los Cabos BCS, Mexico , 30 days after the close of the contest, one (1) Grand Prize winner will be randomly selected in a drawing from all eligible Entries received throughout the Promotion Period. The drawing will be conducted by Sponsor or its designee, using randomization methods selected by Sponsor in its sole discretion. Decisions of the Sponsor shall be final and binding in all matters related to the selection of the winners. The potential winner shall be contacted on or about November 25, 2019, using the e-mail associated with the Entry. Sponsor is not responsible for any failure of delivery of notice attempting to use such methods.
